Chesapeake Inn Transportation Agreement

Please review the following terms and agreements pertaining to your Transportation Rental.

A 50% non-refundable **deposit** is due at the signing of the contract. There is a 10 day cancellation policy. You may cancel your reservation up to 10 days prior to your reservation date and will only forfeit your deposit. If you cancel within 10 days of your reservation date, you are financially responsible for the total amount of your reservation.

Final Payment for the shuttle bus is due in full 10 days prior to your reservation date. If payment is not received 10 days prior to your reservation date, the Chesapeake Inn reserves the right to rent the vehicle to another party with no refund of deposits to you.

Unless otherwise specified, all reservations are required to be paid using a major credit card or cash. No personal or cashier's checks will be accepted. Reservations are finalized upon receipt of a signed contract/agreement.

Additional charges:

- Delays may occur due to unforeseen events. There is no extra charge for the first 30 minutes of delay. After 30 minutes, there is an extra charge of \$25 for every 15 minutes of waiting time up to an hour. If an hour wait time is reached, the additional hourly rates will apply.
- A \$75 surcharge may be applied to the normal rates for any trip beginning before 6am or after 12am and certain holidays or special events hosted by the Chesapeake Inn.
- Each additional hour the vehicle is used but not previously scheduled for, there will be a \$110 charge per hour and must be paid on site and in cash unless otherwise agreed upon in advance.

All transportation vehicles are NON-SMOKING.

1 cooler is permitted to be brought inside the vehicle. It must contain ice packs, no loose ice, and safely fit out of the walking area of the vehicle.

No glitter, confetti or bubbles are permitted to be thrown or used inside the vehicle.

No possession, sale or use of any type of narcotics or illegal drugs are permitted. Violations will result in immediate termination of contract and services and forfeiture of all paid deposits and fees for service.

Client and renter are responsible for his/her guests, for any damage to the interior and equipment of the vehicle. All vehicles are thoroughly cleaned and checked for damage prior to each engagement. This includes but is not limited to: breakage of champagne, wine and drink glasses, decanters, breakage of lights, television, radio, bluetooth sound system, tears or burns in fabric, upholstery, flooring or blinds. Repair and replacement of items shall have a minimum charge of \$150 up to the full cost of repair or replacement of items or equipment.

Cleaning fee:

Standard use cleaning is acceptable. If deep cleaning is needed as a result of but not limited to vomit, blood, urine, wine, make-up, gum, smoke, pets, etc. there will be a minimum of \$500 charge.

All passengers agree to behave in an orderly and well-behaved manner. The Chesapeake Inn reserves the right to expel any person from the vehicle and/or terminate this contract in the event of a violation of any of these conditions by any passenger. In the event of such early termination, no portion of the rental fees shall be refunded.

No more than 15 passengers are permitted to ride in the vehicle. No exceptions.

While we are happy to let you bring various personal items on board, we do not take any responsibility for items that are left in the vehicle during or after completion of the transportation rental period.
